Telepizza publishes 2019 results and bondholder report

Madrid, Spain — April 16, 2020, 10:00 a.m.

Foodco Bondco, S.A.U. (formerly, Tasty Bondco 1, S.A.U.), a subsidiary of Telepizza Group S.A. (together with its subsidiaries, the “Group”), announced today that it has published the Group’s 2019 results and related bondholder report on its website (<https://www.telepizza.com/en/investors/telepizza-investor-relations/>).

The Group’s 2019 results do not reflect the impact of the outbreak of novel coronavirus COVID-19. The COVID-19 pandemic and measures undertaken to reduce its spread present a significant challenge to the Group’s business. At this time, the Group is unable to accurately predict the impact that COVID-19 will have on its operations due to uncertainties, including the severity and duration of the outbreak, and actions that may be taken by governmental authorities. The Group intends to provide a more detailed assessment of the impact of COVID-19, which will be significant, on its results of operations, financial condition and liquidity in connection with the delivery of its report for the three months ended March 31, 2020.
